Purchase of Load and Go Utility Body for S121 (Fire Support Vehicle)- Discussion/Approval Chief Stone informed the Board that we sold the camper for \$5,500.00. The Chief would like to add a Load and Go Utility bed for S121. This vehicle has proven to be the best for fire support, so the addition of a utility bed would allow the equipment to be more organized and accessible. Since the cost is \$8,000, the Chief would like to put it on hold for now and possibly revisit next year.

B. Calaveras Community Foundation Grant- Central Fire received the grant for the Firewood Elves Association. They received a grant for ~\$49,0000 to purchase chainsaws, log splitters, safety equipment and help with wood delivery. The Fire wood elves program is too new to receive the money, so it will be managed by Central with separate County codes for revenue and expenditure, to keep all monies separate.

C. VFA Grant Resolution 2017-10 This is a 50/50 match grant that Central has received in the past. The Chief will purchase items we needed to buy like wildland gear, pagers, helmets and nozzles. Director Mills made a motion to approve Resolution 2017-10 and approve the purchase of items required to meet the 50/50 match on the grant. Director Overacker seconded. (Ayes- Director Cook, Director Overacker and Director Mills, Absent Director Barr and Director Genochio)

D. Facilities Situation Report- Marty Tedder evaluated the condition of all of our Stations and wrote a report listed all repairs needed. The most immediate repair that Chief would like to address is the Station#2 roof. It is in need of repair before winter at a cost of \$2,650. Director Mills made a motion to

E. Strategic Plan- Organizational Structure- Discussion

Since Measure E did not pass by the $\frac{2}{3}$ vote required, Chief Stone would like to come to the Board next month with a plan for budgeting Central Fire through next year. Starting in January, Chief Stone would like to reduce his position from part time to a volunteer position with a stipend of \$960.00 per pay period with no benefits. By the end of the year the two Captains positions must be paid out and eliminated as per the SAFER Grant. Captain Gonzalez will be made a Senior Captain and the District will pay 100% of his medical benefits but he will pay for any dependents. Captain Berlier will be rehired at \$12.37/hr with no benefits. Cal Pers retirement and sick time accrual will be maintained as required by law. The 3rd Captain position will be filled by a Volunteer Lieutenant who is paid a daily stipend of \$150.00 per shift with no benefits.

Policy and Procedure Section #5060 Lines 11 & 12- Correction of Conflicting Language-Discussion/Approval Chief Stone requested the Board approve removal of two lines in Policy and Procedure Section # 5060 lines 11 & 12. When the Policy and Procedures were revised, two lines from the old Policy and Procedures were not removed as intended. These create a conflict and should be removed for clarity. Director Mills made a motion to remove the old language from the revised Policy and Procedure Section # 5060 lines 11 & 12. Director Overacker seconded.
