August was a very busy month for Central Calaveras Fire. The month started with a weeklong deployment to the Aspen Fire in Fresno County. Mid month, Central Fire assisted CalFire with limiting a vegetation fire to approximately 10 acres in the Sun Mountain Road area of Sheep Ranch. Two days later, Central Fire assisted Cal Fire and Murphy's Fire with a vegetation fire in the Parrots Ferry / Natural Bridges area. Central Fire sent an Engine and Water Tender to the incident.

On August 20th, Central Fire Engine 121 was deployed for two weeks on the Rim Fire in Tuolumne County. The Rim Fire grew to more than 255,000 acres and is the 3rd largest fire in California history. It has yet to be fully contained. While Engine 121 was assigned to the Rim Fire, Central Fire staffed Engine 123 as part of an In County Strike Team to ensure that adequate fire resources were available in Central Fire's District as well as Calaveras County.

On August 28th, Central Calaveras Fire Engine 123, Water Tender 121, and Chief 120 responded to a reported structure fire in the Mountain Ranch area. The first engine on scene (a CalFire Engine assigned to the Esperanza Station) arrived they found a partially involved structure and were told that two occupants were still inside the structure. A rescue attempt was initiated and crews entered the building but were unable to locate any occupants and were forced out of the building by heavy fire conditions.

As additional fire apparatus arrived on scene, the fire spreading to the nearby vegetation was extinguished and the fire in the structure was also extinguished. The residence incurred extensive damage.

The subsequent investigation determined that two adult males had escaped from the fire. An adult female and adult male were unable to escape and perished in the fire.

Central Fire was assisted by San Andreas Fire, Mokelumne Hill Fire, West Point Fire, Altaville-Melones Fire, Angels City Fire, Calco Fire, Cal Fire, Calaveras County Sheriff's Office, and volunteers from the American Red Cross who assisted the survivors with relocating after the fire.

In April, Central Calaveras Firefighters completed training in: Vehicle Maintenance, Traffic Control / Safety, Firefighter Proficiency (Wildfire Safety and Fire Shelters), Rural Water Supply, Fireline Safety for Equipment Operators.

With community support, the Firefighter's Association paid for the installation of a solar powered automatic pump switch for the water tank that supplies the fire hydrants in Mountain Ranch. The switch was installed by a local company, PumpCo, and will ensure that this vital water source will be available when needed for fire protection in the Mountain Ranch community. A new water level gauge was also installed in the water tank located on Worden Road that provides water for fire protection in that area. This will enable the District to ensure that water source is available when needed.

Central Fire hosted a county wide disaster drill exercise on April 20th in the Mountain Ranch area. Over 110 volunteers from multiple county and state agencies and private partners (PG&E) participated in the drill. Central Fire firefighters, CERT members, and local Red Cross volunteers participated in the drill. The Mountain Ranch Community Club was successfully utilized as a shelter with the cooperation of Calaveras County OES, CalWorks, Red Cross and other County and State agencies.

CalFire: The new Unit Chief position for CalFire has been filled by Josh White. CalFire started Fire Season May 1st. Burn permits are now required and burning is restricted to night hours. Over the weekend of May 4th-5th, a Strike Team of Engines from Calaveras County responded to the Springs Fire in Southern California and during that time period Central Fire E121 was on an In-County cover assignment providing fire protection coverage for the County.


CalFire: the unit Chief position for CalFire has not yet been filled – however is expected soon. Groveland Fire District has contracted with CalFire to provide fire protection services under a Schedule A contract. Previously, Groveland had a budget of over 1 million dollars but due to budget cuts a contractual arrangement was reached with CalFire to provide the services. The career Groveland firefighters were transitioned to CalFire under the arrangement and the Groveland volunteer firefighters are now administered by Tuolumne County.

CalFire expects to start fire season staffing on May 13th, adding additional engines on May 20th, and reach full staffing by June 10th. The January – March period was one of the driest in recorded weather history and the dry fuel conditions will likely result in a larger number of fires reaching larger proportions this fire season.
