## PARTICIPANT CONSENT, WAIVER AND RELEASE FROM LIABILITY 2018 Stop, Drop & Mud 5K Race presented by Central Calaveras Firefighter Association

I am covered by medical insurance, individually or as part of an organization.

I assume all risks associated with my participation in the Event and the risk of injury caused by the condition of any property, facilities or equipment used during the Event, which may not be reasonably foreseeable by anyone at any time. On behalf of myself, my executors, administrators, heirs, next of kin, successors, and assigns, and anyone else who might attempt to sue on my behalf, I HEREBY WAIVE, RELEASE, and FOREVER DISCHARGE all Event sponsors, Event producers, Event staff, administrators, officials, contractors, vendors, and organizers(including race directors), volunteers, and all other persons or entities involved with the Event, states, cities, towns, and other governmental bodies and locations in which the Events or portions of Events take place, and the officers, directors, employees, agents, insurers, and representatives of all of the above, including but not limited to Central Calaveras Fire & Rescue Protection District, Central Calaveras Firefighters Association, Senders El Dorado Ranch, LLC., along with their parent companies, affiliates, and their successors and assigns ('Companies") their respective employees, agents, or volunteers from any and all claims, causes of action, damages, losses (economic and non-economic), and liabilities of every kind, for death, personal injury, or property damage, which may arise out of, result from, or relate to my participation in, or my traveling to or from the Event, or for any injuries, losses, damages, claims, liabilities or expenses that are caused or alleged to be caused by their negligent acts or omissions, or the condition of the property, facilities or equipment used for the Event.
